It is a pleasure to announce The Fourteenth Dewey Beach Art and Fun Fest.

The show is sponsored by the Dewey Business Partnership, a nonprofit 501c(6) organization dedicated to the enhancement and quality of life in Dewey Beach. The show benefits the Dewey Business Partnership's town and visitor sponsored activities. The Arts Fest offers customers many unique gift options for Mother's Day, Sunday, May 10th. Again, it will take place outdoors on the bayside of Dickinson Street which intersects with Route One, also known as Coastal Highway.

The History: In 2012 the Dewey Business Partnership introduced the first Dewey Art Fest with 35 Artists. The attendance was overwhelming and indicated it was a welcomed event for the Town of Dewey Beach and visitors coming from all over. While the event was cancelled several times due to a Nor'Eastern then COVID, it again proved to be a huge success with more and more artists wanting to be involved. We sincerely hope that this coming year will go as planned and be a huge success.

Application Deadline: Postmarked by April 10, 2026. No late applications will be accepted.

Acceptance Email Letters will be sent shortly in the form of a "Welcome Letter" after the deadline based on when the jury can meet.

Rain Date: No rain date

Artwork must be original with the Artists in attendance.

REFUNDS: No refunds will be given after May 1 if artist cancels.

Refunds will be returned or destroyed if show is canceled. The show will be cancelled if the weather is a threat to human life, unsafe conditions or if health restrictions cause us to do so.

Mediums Accepted

Clay, digital art, drawings and graphics, fiber, glass, jewelry, leather, metal, mixed media, painting, photography, print making, soap and fragrances, candles, sculpture, watercolor, wax, wood, textiles
Work must be original by the artist who MUST be present at all times.

No commercially, massed produced or kit-made items allowed.

Booth Information

Spaces are 10X10 and allocated for a **10x10** canopy or tent. White tents are preferred, however any color is acceptable as long as the tent is clean, neat and free of commercial logos. For example, a tent with a "Miller Lite" logo is not acceptable. Artist logos are acceptable. Please be prepared to secure your tent for there is always the chance of an unpredictable wind. If it is not secured we will ask you to take it down. If the weather should turn, the Dewey Business Partnership has the right to call the show to end early.

All displays **MUST** look professional and pleasing to the eye. All signs must look professional. All spaces will be marked. Note: Backyard "screen houses" are not acceptable tents.

Parking:

The artists who have cars, SUVs or Vans **WILL once again be able to park directly with their space.** Your vehicle will need to stay in your space for the entire duration of the show. If an artist has an RV, large trailer or needs to get in and out, they will need to unload their vehicle and park in another area. If two artist spaces are purchased, two parking spaces will be included. The spaces will be marked and volunteers will be available to guide you to your space and provide help if you need it.

Set-up and break-down

Set-up times will be staggered beginning at 6:00 a.m., 6:30 a.m., 7:00 a.m. 7:30 a.m., and 8:00 a.m. This will allow for easy traffic flow. **Any space not occupied by 8:30 a.m. will be considered a "no show."** All spaces must be vacated by 4:00 p.m. the day of the show. Trash must be cleaned up.

Artists are VIP's:

- *Volunteers will be available to booth-sit, set-up and break down
- *Ribbons and prizes awarded for best of show and best booth display.
- *Free morning coffee, beverages, and breakfast treats.
- *Two restaurants are also on site
- *Complimentary artist gift bag
- *Bathrooms are on site.
- *On-site security provided by the Dewey Beach Police Department
- ***No commissions collected for sales!**

Marketing

The Dewey Beach Arts Fest will be advertised in most media outlets in Delaware, Pennsylvania, Maryland, New Jersey, Virginia and Washington, D.C. through the Dewey Business Partnership and the Rehoboth-Dewey Beach Chamber of Commerce. 100 percent of the fees go towards marketing and show preparations.

Insurance and Finances Artists are responsible for their **own insurance** and **financial responsibilities**.

There is no sales tax in Delaware. **We do NOT take a commission! There is an ATM machine at the end of parking lot.**
